RE: Calling the Meeting to Order

Mayor Jon Bagley called the regular monthly meeting to order at 7:00pm.

RE: Approval of Minutes

The Board reviewed the minutes from the July 14, 2014 board meeting. A motion was made by Trustee John Sawers to approve the minutes as printed. Trustee Chuck Elwell seconded the motion. Unanimously carried.

RE: Public Work's Supervisor: Art Rilands

Construction work on Bassett Street continues and Art would like to put the blacktop down on Bassett Street by the end on the month. Art reported that the sidewalks for the north side of Gilbert Street have not been scheduled yet.

Art reported that MRB group is still doing work on the sewer study and will be coming to September 8th meeting to talk about the results of the sewer planning study.

The chlorine line at the water plant is still plugged. It is difficult for a diver to see what work needs to be done on the chlorine line because Canandaigua Lake is very cloudy with limited visibility.

RE: Safe Routes to School Sidewalks Project

A date has not been scheduled to start work on the north side of Gilbert Street.

NEW: MWCSO Sidewalk Project Agreement

Trustee John Sawers made the motion to amend the project agreement with MWCSO for the Safe Routes to School Sidewalks Project and Trustee David Field seconded the motion. Unanimously carried

RE: Bay Water Easement

Village Clerk Jennifer Gruschow will contact Attorney Kenyon to see what has been done to redraft the easement.

RE: Sewer Planning Study

MRB Group, with Art's assistance, completed a flow test to check wastewater levels in the sewer lines. This test occurred at night in order to ensure the minimal amount of water usage, to increase chances that the flows in the lines were from infiltration and not normal household use. MRB Group still plans to do two more investigative work. They will conduct a smoke test towards the end of the month, which consists of blowing a non-toxic smoke through the sewer lines to make sure there are no leaks in the lines and if there are any leaks then the smoke will identify the area.

RE: Drainage Issues at 21 Gilbert Street

The Village is waiting for a permission letter from Dale LeClair to have access to her property.

NEW: Plaque for History Room

Mayor Jon Bagley would like to order a plaque for the History Room to show appreciation and recognition to all who put their personal time and effort in getting the History Room set up. Mayor Jon Bagley will ask Historian Jim Rice to assist in gathering names.

RE: Public Comments

A motion was made by Trustee Chuck Elwell and seconded by Trustee John Sawers to authorize payment of the safe routes to school sidewalks project bills in amount of \$34,621.55. Unanimously carried.
